Kevin's Corner

Are We There Yet? How many MORE people does Riverside County and its cities need to add before we can say, "sorry but the motel (county) is full!" (note: roughly 30,000 new residents join us all each year).

The fact is, it's NOT even an option for us to say we are full. And indeed, some could easily make the argument that nor should we ever say we have no room left in a state as massive as ours.

The folks who align with *The Overpopulation Project* movement make an argument that our limited resources cannot sustain our trajectory. A more locally based argument can be advanced that our stalled traffic on the 15, 215 or the 91 parking lot freeways, our recent rolling power brown-outs, our inadequate statewide reservoir storage, our hospitals and/or mental health facilities constantly being at capacity, as well as our strained taxpayer funds are all screaming at us with BIG red warning signs.

A local case in point. Nearly every one of our local freeways achieve stand still status (known as service level "F") nearly every commuter day. The 15 freeway is no exception and needs immediate expansions to facilitate local residents heading to and from work, and of course the out of town commuters, vacationers, truckers, etc, who pass through on their way to San Diego or Orange Counties and beyond. In hoping to address this critical need, the Riverside County Transportation Commission (RCTC, which is not a "county department") has been planning a widening project down the 15. The preliminary cost to add two lanes in each direction between Corona and Lake Elsinore is an astounding \$652 million +. The County and cities have nowhere near anything even close to that kind of funding available. And to make matters worse, for such a project to even be considered for state and/or federal funding, it would need to be a toll lane project (government calls those "Express Lanes" to avoid even mentioning toll fees). Without the toll revenues to pay back state and/or federal loan guarantees, no grants, no loans = no project. So, if I understand things, the State of California is mandating to our county and cities that they plan, zone, and make available the ability to add 167,000 more affordable homes across Riverside County, while we simultaneously have had to deal with power shortages, water shortages, and jam packed freeways that will not receive state financial assistance to expand unless we make them toll lanes, so that poor and blue collar working stiff's cannot even afford to use them? *Sorry, but I'm confused.*

Full Court Press... Last month, I reported on the on-going saga of our understaffed courts (lack of judges), and the growing number of criminal cases being dismissed before trial by the courts (which includes a large number of felony cases). Our local ratio of judicial officers per 100,000 residents is 3.4, compared to a statewide average of 11.4. In short Riverside County is at least 22 judges short to

handle the workload (assuming all of our judges are working full time 5 days a week). The battle to fix this injustice (staffing) is now moving to the State Capital in Sacramento. Our local State Senator Richard Roth has introduced SB-75 to have the State fund the additional judges for our county and others. My guess this will be a brutal fight in the State Legislature. Our State is not exactly known for desiring to enhance the judicial branch anywhere in California. As we hear more about this uphill effort, we may need to send letters to our legislators asking for support. More to come.


Short Changed! Back in March 2019, the County had estimated that the state of California was short-changing our residents to the tune of at least \$140 million a year, every year, for (just) county wide mental health services. This disparity has been caused by a discriminatory state population funding formula that rewards or protects coastal counties at the expense of the faster growing inland counties. I hope to provide you with some updated numbers in the near future to determine if things have improved (or not). I fear that I already know the answer.

As always, feel free to write me with your constructive thoughts to help improve our quality of life in Riverside County, or to simply vent about ways to improve services. Remember, I can only work on county government issues, I have no say in city provided services.

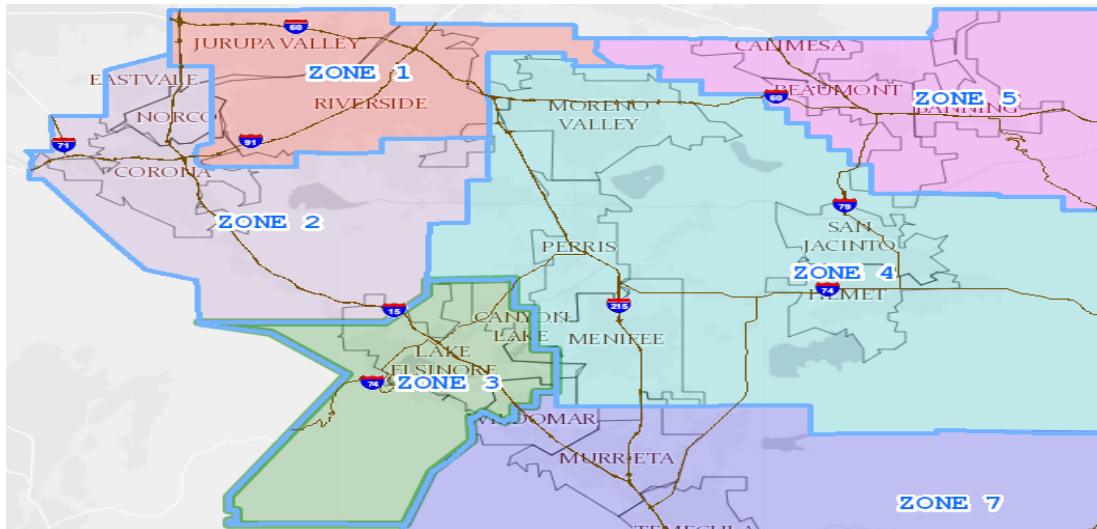

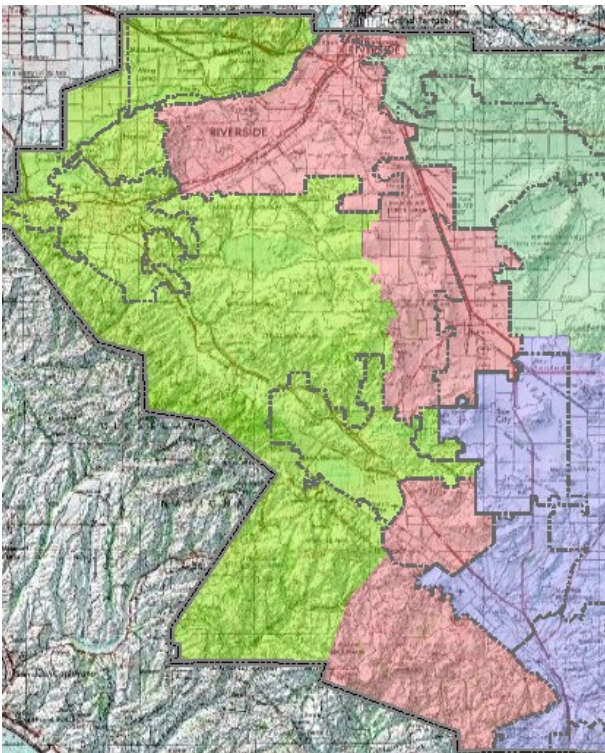

Renters and their guests should park in the rental garage, driveway, or on the property. No street parking will be permitted.

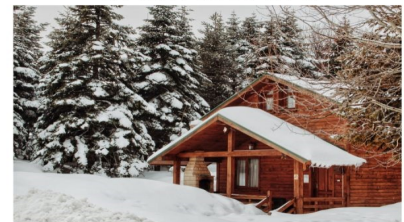
TRASH:

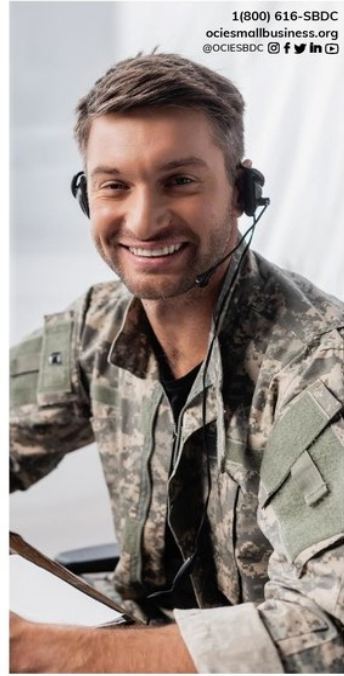
