Daylight the Budget---At Night! This Tuesday, May 7th, the Board of Supervisors will be presented the Third Quarter budget review. While to most folks this presentation would help overcome any sleep insomnia, it really serves as an indicator as to what is on the horizon for the new July 1st budget. There will be several public discussions about the proposed Fiscal Year 19/20 budget, and this year, I have asked that one of those public meetings will be held at night, so that constituents with day jobs might attend. That meeting will be **Monday June 10th at 6pm** in the County Administrative Center, downtown Riverside. So if you have a passion for a particular public service to be adequately funded (at a time when the State is squeezing all 58 counties to provide more services with less money), this meeting is for you!

Regulating the Black (Green) Market. For the past year or two, the County of Riverside has been navigating newly implemented State laws and regulations regarding future cannabis dispensaries and cultivators. Our new County regulations have now been adopted, the all-important government fee structure has been set, and 127 "preliminary" applicants recently submitted for background checks and an additional review process. Because the final submittal of each qualified proposal will come to the Board of Supervisors for approval, my fellow Board Members and I have intentionally kept an arms-length distance from learning about the specific applicants during this scoring stage. Once applicants are given the green light to move forward into the official permit application process, they will be required by our office to make public presentations to local unincorporated community organizations. If you have any questions (in the First District) about your community please give us a call. Please note that all city applications/ procedures are handled by the local city council.

New Board, New Leadership, New Accountability. Over the past six (6) years (January 2013 to present) there has been a 100% turnover of the Board of Supervisors. I have only six years on the Board and I'm now the senior Board Member. Supervisor Washington replaced Jeff Stone after he was elected to the State Senate in 2014. Supervisor Perez replaced the late Supervisor Benoit after he passed away in 2016, and Supervisor Spiegel and Supervisor Hewitt replaced Supervisors Tavaglione and Ashley respectively when they retired this past November. To add further to the changing of the guard, Mike Hestrin became of our new (elected) Riverside County District Attorney in 2014, and Chad Bianco became our newly elected Riverside County Sheriff this past November. For better or for worse, these new changes over the past six years represent some significant new blood in critical leadership positions across your county. The challenge, of course, is to translate that new leadership into new management directions and new levels of accountability for the benefit of all who call Riverside County home. Your county government is a very big institution (bureaucracy) with nearly 22,000 employees serving 2.4 million residents with a \$5+ billion budget in the fourth most populous county in our state (and the 10th largest in the nation).

However, if you want to experience frustration, try changing 20 to 30 years of “this is the way we’ve always done business.” Unless you are digging, you are not going to notice some of the changes that have already occurred. Some department heads have moved on, litigation settlements are resulting in swifter action when negligence occurred, and enhanced oversight and accountability is occurring with the use of county (taxpayer) funds. Now to be sure, we have a lot of financial and leadership challenges ahead for our growing county (nearly 30,000 new residents added last year). Much more needs to be done on all fronts.

As always, if you have suggestions, please do not hesitate to drop us a note or email. The amount of valuable information we receive from customers, vendors and current or retired employees is impressive. It helps our office to be able to dig in and research how to make your local government more efficient and transparent. (Sorry, but I can’t help you with our State or Federal government).

GRID Alternatives

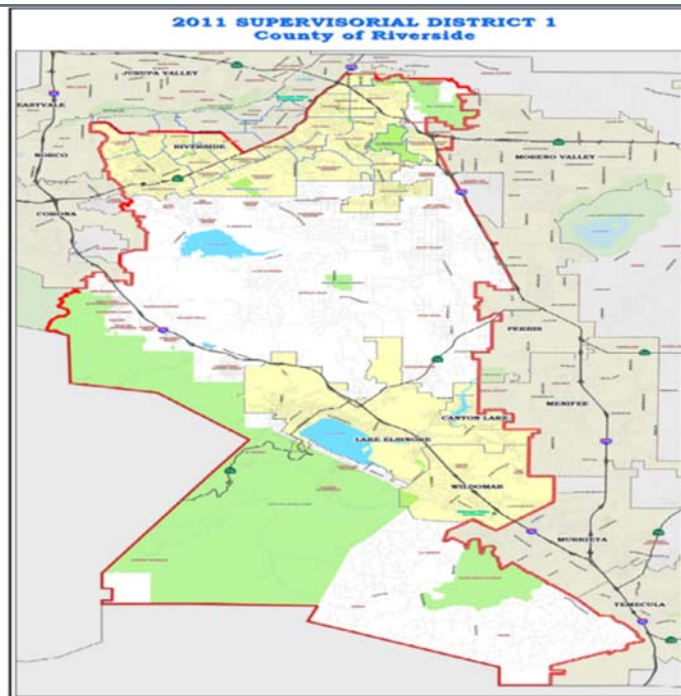
GRID was founded during the 2001 California energy crisis by Erica Mackie, P.E., and Tim Sears, P.E., two engineering professionals who were implementing large-scale renewable energy and energy efficiency projects for the private sector. The idea that drove them was simple: free, clean electricity from the sun should be available to everyone. Through GRID Alternatives, they developed a model to make solar PV technology practical and accessible for low-income communities, while providing pathways to clean energy jobs.

GRID completed its first single-family installation for the Cubas family of San Francisco in 2004. In 2008, GRID was selected by the California Public Utilities Commission to serve as the statewide program manager for its groundbreaking Single-family Affordable Solar Homes (SASH) incentive program, prompting an expansion across California.

Today, GRID is a leading voice in low-income solar policy and the nation's largest nonprofit solar installer, serving families throughout California, Colorado, the Mid-Atlantic region, and tribal communities nationwide. Our Energy for All Program (formerly Solar Affordable Housing Program) offers single-family, multifamily and community solar installation services, project development and technical assistance, and we offer multiple levels of workforce development and service learning opportunities, from volunteerism to in-depth solar training and paid internships.

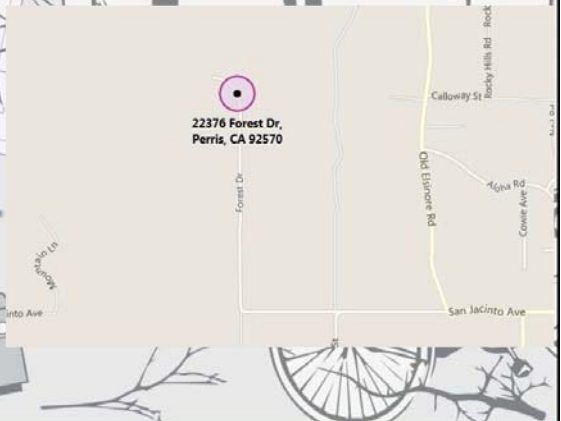

Acceptable Items

- **Tires:** Per state law, please only transport 9 tires per trip. Please call Riverside County Waste Management Department for a waiver if needed. Tires must be less than 4ft in diameter & weigh less than 200 lbs.
- **Furniture:** Sofa beds, couches, tables, chairs, mattresses, box springs and patio furniture.
- **Large Appliances:** Washing machines, dryers, stoves refrigerators, water heaters, air conditioners and dishwashers.
- **Tree Limbs and Branches:** Should not exceed 18 inches in diameter or 3 feet in length. Please make sure tree limbs are bundled and tied together.
- **Electronic Waste (E-Waste):** Computers, monitors, printers, old televisions and other electronic devices with a plug or circuit board.
- **Other Items:** Bicycles, barbecues, swing sets, and small appliances

Unacceptable Items

- **Fluorescent light bulbs**
- **Pesticides/Fertilizers**
- **Weed Killers/Herbicides**
- **Rodent Poisons**
- **Latex, Oil, or Water based Paint**
- **Batteries**
- **Motor Parts**
- **Solvents/Gasoline**
- **Transmission/brake fluid**
- **Bleach/tub & Tile Cleaners**
- **Empty Drums**
- **Anti-Freeze**
- **Pool Chemicals**
- **Engines**
- **Motor oil and Other Hazardous**
- **Concrete or construction/demolition materials**
