## Kevin's Corner

*This month's Corner is all over the map – so here we go....*

**Proposed Good Neighbor Policy** – Is Not So Good, Yet. For roughly 2 years, I have been pushing our county to develop specific development standards that would apply to proposed warehouses, with an emphasis on protecting existing nearby homes and schools. While dense landscaping (trees) can hide the not-so-pretty big box buildings, they cannot hide the emissions that come from the tractor-trailer rigs. A recent report indicated that when warehouses are located at least 1000 feet from homes, the diesel emissions from the trucks can dissipate by roughly 80%. A recent proposal from county staff only proposed a separation of 300 feet (at best). This proposal will be brought back to the Board again on Nov. 19<sup>th</sup>.

**More Homes?** Through a very convoluted, state-required process, layers of largely unaccountable government bureaucracies evaluate and then mandate how many new home sites must be made available through local land use and zoning laws. The good folks who decide the "Regional Housing Needs Assessment" for Riverside County have tentatively concluded that we MUST add 235,000 more homes across our county. 46,000 of those homes are proposed for our unincorporated (non-city) communities. It does not matter that our unincorporated (mostly rural communities) lack the needed infrastructure to support this level of new homes. Just to compare, last year San Bernardino County, which has a similar population to our county was only required to add 39 homes - YES 39! Other targets for new housing units in the 1<sup>st</sup> District are 192 for Canyon Lake, 12,217 for Lake Elsinore, 20,126 for City of Riverside, and 4,963 for Wildomar.

**New Traffic Signals.** With our freeways serving as parking lots during our commuter hours, many of us end up using back roads to get around. For those who reside in some of our unincorporated (non-city) communities, you may often find yourself unable to get out of your neighborhood. To try to control some of this traffic, three First District communities will soon see new traffic signals. **University City** (near 215 & Box Springs) will have a signal added at Sycamore Canyon Road and Minnesota Way. For the **Woodcrest** community, a new signal is now in planning for Washington St. and Saddleback St, and in the community of **Good Hope**, a signal has been approved for Highway 74 & Sophie Street. The cost? Roughly \$450,000+ each. Fortunately, this money comes from a state-restricted pot of money for safety improvements that could not otherwise be spent on Sheriff, Code, or Fire.

**Local Road Improvements.** The **City of Wildomar** recently secured \$3.5 million from the Riverside County Transportation Commission (RCTC) in order to start planning the widening of Bundy Canyon Road. The unincorporated community of **Mead Valley** was funded \$7.4 million (with \$3.7 million coming from the Feds and \$3.7 million coming from the County) to start widening and adding needed traffic safety improvements on a 2 mile stretch of Cajalco Road, from Day Street to Brown Street. The **Temescal Valley** and **El Cerrito** communities will hopefully soon be funded with \$3 million from the Western Riverside County Council of Governments (TUMF funds) to continue the County's efforts to widen Temescal Canyon Road (in phases) from the City of Corona to Lake Elsinore. And, a long term study is underway near the community of **Good Hope** involving the cities of **Perris** and **Menifee** to extend Ethanac Road west from the 215 to Hwy 74. If you're scratching your head wondering, "What is being done about our freeways?" I will try to cover that in the near future with updates from Caltrans (who owns them), and the Riverside County Transportation Commission (RCTC) (who tries to improve them).

**Wild Fires.** On a closing note, at the time of this publication, our local firefighters were already engaged across the State helping with numerous fires. Things were so bad at one time that the Incident Commander of a wildland fire near Napa requested 200 fire engines. Help our firefighters help you, and please make sure you have "Defensible Space" around your home!

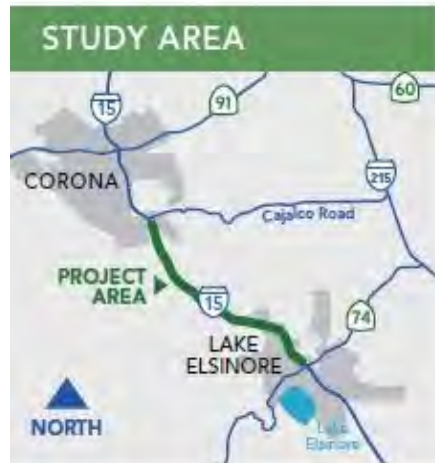

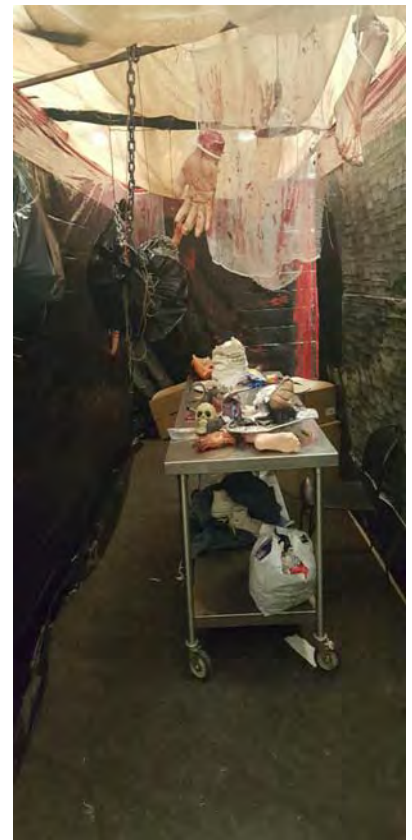

## District Attorney Crime Prevention Foundation

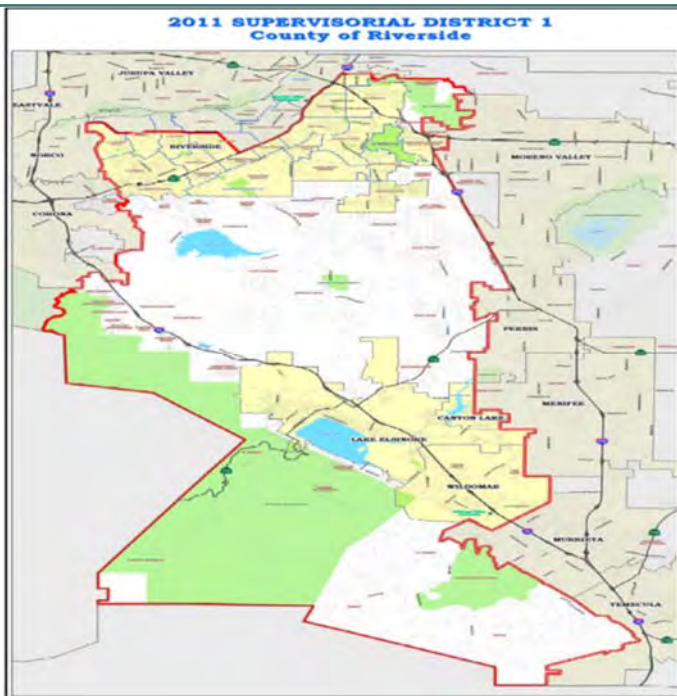
The core mission of the District Attorney's Office is criminal prosecution, but crime prevention is also a critically important part of what DAs do. Fittingly, the DACPF's mission is to create crime prevention programs and activities in partnership with stakeholders and Non-Governmental Organizations (NGO) in the community. For example, one such program will facilitate the re-entry into society of previously convicted felons who demonstrate the willingness to better themselves and their community. In doing so, the DACPF provides opportunities for success to those who sincerely want a second chance.

Initiatives supported by DACPF are crafted to prevent crime, improve access to employment for previously convicted felons who meet certain criteria and to increase options to divert youth from the criminal justice system. With this in mind, the DACPF is focused on providing grants for programs that improve public safety and prevent crime. The DACPF will support community partners in an effort to prevent crime. Potential beneficiaries of the fund include non-profit organizations that assist in prisoner re-entry, divert at-risk youth, and/or prevent domestic violence and curb human trafficking. Neighborhood safety programs round out the list.
